For shipment consists of wood packaging materials have to be treated and marked in accordance with the requirements of the International Standard on Phytosanitary Measures (ISPM 15) - "Guidelines for Regulating Wood Packaging Material in International Trade" of International Plant Protection Convention (IPPC). Exhibitor should provide original Fumigation/Heat Treatment Certificate, which is issued by government authorities. If there's no wood packaging material in the shipment, exhibitor/shipper should provide an original "Letter of Certificate" to certify the kind of packing materials.

3.3.3.SHIPPING ROUTE 运输路线

According to the general practice, all the shipments of "Exhibition Goods" should be consolidated in Hong Kong and then transport to Dongguan for proceeding Customs Declaration. So the Overseas Shipments

(LCL sea freight and air shipments) should send to Hong Kong port/airport, and Local Shipments should arrange delivery (or order us to pick up) to our Hong Kong warehouse, we will then make the consolidation and on-forward the shipments to Dongguan.

3.3.6. INFORMATION ON SHIPMENT VIA HONGKONG

经香港转运货物的注意事项

- a) Documents needed for Hong Kong SAR Transit Customs 香港转运文件
 - i)3 copies of Commercial Invoice with exact description of each item, quantity and CIF value. 3份发票, 发票上须详细列明每件展品的内容, 数量及到岸价格;
 - ii) 3 copies of Packing List with all above details plus measurement, weight and contents of each package.

3份装箱单,除有上述内容外还须列出尺寸,重量及每箱所装内容;

iii) 1 copy of Insurance policy cover of the exhibits.
1份货物保险单的复印本。

b) Transit customs procedures in Hong Kong SAR 香港转运手续

All exhibits are subject to Hong Kong SAR Import / Export Regulation. Exhibits must be imported and re-exported with payment of Customs Declaration Fee to the Trade Department of Hong Kong SAR. (This also applies to temporary importation).

所有展品经过香港,都要按照香港海关规定申报进出口(含临时进口和再出口),及向香港贸易署 支付有关费用。

c) Dutiable Goods in Hong Kong SAR 须在香港特区交纳税款的货物

Cigarettes, Wine and Spirits are considered as dutiable goods in Hong Kong SAR. Exhibitors sending such exhibits to Hong Kong SAR for trans-shipment to China should pay attention to Hong Kong SAR Customs regulations. Duty will be paid in advance by the official freight forwarder on behalf of shippers upon cargo arrival.

香烟、葡萄酒及酒精饮料须在香港特区交纳税款,在香港中转此类展品的参展商需要注意此项海关规定,税款在货物到达时由运输代理替参展商垫付。

Thus following documents are required for customs clearance in Hong Kong SAR 需提供下述文件:

- i) Invoice 发票;
- ii) Insurance certificate with Insurance Premium 保险单;
- iii) Bill of Lading or Master Air waybill 运单。

d) Specific documents needed for strategic commodities in Hong Kong SAR 经香港转运的受控商品

Strategic commodities are goods covered by the schedule to the Import and Export (Strategic Commodities) Regulation, Cap. 60. Computers, Telecommunication Equipment's, etc. belong to this category. Exhibitors who wish to exhibit these items are requested to send us a copy of relevant export license issued by Government of Origin Country and 3 copies of catalog giving technical details of the goods. These documents should reach us in accordance with our TIME SCHEDULE.

受控制商品,如:电脑、技术设备等类货物须遵守香港特区对此类商品的规定。如参展商发运此类展品须提供当地政府部门出具的原产地证明(1份复印件)及3份有关产品技术介绍及说明的技术资料,并在主场运输要求的时间内提供上述文件。

3.3.7.CATALOGUES AND TECHNICAL INFORMATION 印刷及音像资料

According to the rules promulgated by the Ministry of Foreign Trade of China, "Advertising materials and technical information materials including films, lantern slides, recording-tapes, video-tapes, CD Rom, records, photos, maps, illustrations, directions and other publicity materials, shall be allowed for display or use at the exhibition only after the exhibitor has presented beforehand the above-mentioned materials to Customs Officers for inspection and approval."

根据中华人民共和国经贸部发布的规定,"宣传及技术资料,包括电影胶片、幻灯片、录音带、录像带、光盘、磁带、照片、地图、图片、示意图等类宣传资料,须经在海关审查样品同意后才能展出或使用。

Therefore, the exhibitor shall not make use of these materials before censoring. For such a purpose, the exhibitor should send 2 copies of all literature/printed matter, all video tapes, CD Rom and slides (with words introduction is better) to official freight forwarder on-site staff during the move-in period, which will be handed over to the Chinese Customs for censoring in advance.

所以请不要在海关审查前使用上述资料。请参展商将印刷品、录像带、光盘及幻灯片(最好有文字说明)等各准备两份样品交给主场运输的现场工作人员,以便提前转交海关审查。

When Taiwan or Hong Kong SAR is to be mentioned in the promotion materials, the exhibitors should avoid using any expression of interpreting those places are in the position equivalent to a country.

如宣传资料上显示台湾或香港特区,请参展商切勿使用国家等类似字样用于此类地区。

Exhibitors should also submit, through the official freight forwarder, 2pcs of the samples of their souvenirs to the Customs for inspection before being allowed to distribute on-site.

请参展商事先将散发的纪念品样品一式两份交给主场运输用于海关审查。

The item which is used for equipment demonstrations, such as paper, ink etc, with low quantity and value is tax-free. But if the in large quantity or in high announce value, Customs will still levy the Tax & Duty.

用于设备演示、表演所必需的消耗品,如纸张、油墨等,海关规定少量、低价值是免税的。但如果数量巨大、或者金额较高,海关还是会按照相关税率征收关税和增值税。

3.3.8.DANGEROUS GOODS 危险品

Exhibitors need to send us a special form for dangerous goods. These forms will be provided upon request and the completed form should reach us before shipment is dispatched. Surcharge will be imposed for handling of such exhibits.

参展商需向主场运输提供一份危险品的特殊表格,主场运输会在其要求下提供此表格,请参展商在货物发运前将此表传真至主场运输。另外,此类展品将产生附加费用。

3.3.9.PACKING OF EXHIBITS 包装要求

The exhibitor shall be responsible for the consequences of improper packing.

a) Protection against Damage and Rain防雨、及防破损措施

参展商应对其展品的不当包装所造成的后果负责。

Please note that the exhibits are to be repeatedly loaded and unloaded by different parties during the long distance transportation, shocking/bumping will sometimes be inevitable. Moreover, the exhibits will be placed outdoors many times, including open-air storage at the exhibition centre before and after the exhibition sometimes even without a tarpaulin. Therefore, we strongly recommend the Exhibitor to take necessary precautions against damage and rain, especially when the return exhibits are to be packed with original packing materials, which might be damaged already during unpacking.

由于展品在长途运输途中不可避免地被频繁装卸,以及通常在室外存放(有时甚至无防雨油布), 所以包装箱必须制作坚固且能够防雨。尤其是需要在展览结束后回运的展品,其包装箱要求能够重新包 装及用于回运。

b) The Case 木箱

The case must be strong enough to avoid damage during transportation as well as unpacking and in particular be suitable for repacking and for sale or return movement after the exhibition. It is advisable that the gross weight of individual package is between a few hundred kilograms and 2 tons – smaller case will be handled manually and therefore has more chances to get damaged; while too heavy a case will cause heavy lift surcharge.

木箱须足够坚固,以防止在运输、拆装,以及回运过程中产生破损。需要注意的是毛重在几百公斤 到2吨的小件展品由于经常采用手动工具搬运,更易发生破损。大件展品将产生超重附加费。

3.3.10.HEAVY / OVERSIZED EXHIBITS 超重及超大展品

In case you have some bulky cargoes to be shipped to the show (exceeding either 4 tons, or 6m length, 2.2m width and 2.2m height), you have to contact us for prior arrangement.

如有超限展品-重量超过5吨,尺寸超过6米长, 2.2米宽, 2.4米高, 请务必提前与主场运输联系。

Exhibitor with heavy exhibits must arrive on-site early and direct the actual positioning of heavy exhibits. If a mobile crane or forklift is required for installation of equipment, including removing wooden bases, the exhibitor should send their detailed requirements to the official freight forwarder. Quotation of hiring these equipments will be given upon exhibitor's request. A detailed layout should also be provided to the official freight forwarder for better on-site operation.

大件展品需安排提前到达展览现场并告知展品摆放位置。如需用吊机摆放,包括移动木箱,参展商需要向运输代理提供相应细节,租用起重设备的价格将根据参展商的要求报出。请给运输代理提供一份详细的就位图以便操作。

If no layout has been submitted or no instruction are given, exhibits will be delivered and placed arbitrarily on the stand, extra expenses will be levied if the exhibitor requests any repositioning of the exhibits.

如参展商未能提供就位图或指令,展品将被任意摆放在展位上,重新就位将产生附加费用。

3.3.11.CUSTOMS CLEARANCE, UNPACKING & REPACKING 清关, 拆箱及装箱

According to the Customs Regulation of China, it is imperative that all exhibitors should declare what portion of their exhibits will be returned, consumed, OR giveN away when they' re imported into China. And if the exhibits (will be consumed or given away) .Such as consumption, distributed by the value is too high or an excessive number of exhibits, China Customs will collect the appropriate taxes in accordance with regulations.

根据中国海关的规定,参展商必须在进口时即申报其每件展品的处理方式,如:回运、消耗、散发。 如消耗、散发的展品价值过高或者数量过多,中国海关将会按照规定收取相应的税款。

Customs clearance and inspection will be affected stringently on the fair ground according to the "List of Exhibits" (Form A). To expedite smooth clearance and inspection, exhibitors are requested to complete the Form A clearly in both English and Chinese, declare the disposal, and separate pack their shipping items in: 1) Exhibits, 2) Decoration Materials, 3) Office Materials, 4) Catalogues and Souvenirs.

海关将在展览会场按照展品清单严格检查。为使清关和检查顺利进行,参展商必须用中英文填写展品清单,注明处理方式,并将1)展品,2)展架材料,3)办公用品,4)宣传资料和礼品,分开包装。

Exhibitors are highly recommended that a representative of the company is present on-site to supervise the unpacking and repacking during move-in & move-out period. As the customs requires the on-site forwarder to be responsible for every exhibit, exhibitors should not be allowed to unpack their exhibits on-site or take away from the show ground without prior arrangement with the customs through the official freight forwarder. Representative contact details must provide to us at once.

请参展商务必派人到现场督导拆箱及装箱。由于海关要求运输代理对每件展品负责,请参展商不要自行开箱或未经运输代理向海关申报批准而自行将展品带出展馆。请参展商及时提供所派代表的联系方式。

The official freight forwarder will not be responsible for the delay of customs clearance and positioning/displaying of exhibits due to the late arrival of the representative or without receiving the explicit instruction from exhibitors beforehand.

由于未收到参展商清楚的指令或代表晚到而使其展品不能按时清关及就位,运输代理对此将不负责任。

During the move-out period, exhibitors must also supervise the dismantling and repacking of exhibits, especially for delicate or heavy equipment, since these operations will be carried out at exhibitors' risk. When utilizing the used packing materials for repacking, exhibitors must understand that they are responsible for the outcome caused.

在出馆期间,参展商也须督导展品的拆卸、装箱。特别是对于精密或大件展品,参展商应对操作负有全责。

Empty cases will be started to return to stands from the storage place once the exhibition is closed. The official freight forwarder will assist in repacking according to exhibitor's requirements and will go through customs clearance on behalf of exhibitors.

空包装箱将在展览闭幕时从存储地点送到展台,运输代理将根据参展商的要求协助包装并办理清关手续。

3.3.12.CUSTOMS PROCEDURES AT CLOSE OF EXHIBITION 闭馆后的清关手续

Exhibitors must not leave the exhibition before handling over returned exhibits as well as exhibition documents to the official freight forwarder. Once these documents have been processed with relevant Chinese parties, any changes will generally not be accepted.

参展商在未将回运展品及文件交给运输代理前请勿离开展览会。此类文件一经交到相关部门,一般将 不能接受任何改变。

Should the official freight forwarder not receive the signed RETURNED INSTRUCTION on or before the closing day, the official freight forwarder reserves the right to return all exhibits to Hong Kong or the origin port. All cost should be paid by the exhibitor.

如运输代理未能在闭幕前或当天收到参展商签字的回运委托,运输代理有权将所有展品运至香港或运回始发港,由此所产生的全部费用由参展商支付。

3.3.13.INSURANCE 保险

Please be reminded that the official freight forwarder's tariff is worked on the basis of volume or weight and have no correlation with the value of exhibits, therefore no insurance has been covered in our charge and all work is undertaken at owner's risk.

谨此提示,主场运输的收费是基于展品的体积及重量,与展品的价值无关,故此我们的费率内不包含 保险费用。敬请参展商谅解。

It is the responsibility of each exhibitor to cover round trip all risks Marine (Transport) Insurance including the exhibition period and return of the exhibits to domicile, inclusive of the period the exhibits are handled by us, preferably through a company of which the People's Insurance Company of China is the agent in China.

参展商有必要购买全程保险,包括在展览开幕期间、回运到始发地以及由主场运输操作期间。建议通过由中国人民保险公司为代理的保险公司办理保险。

The exhibitor should also bring a copy of the insurance policy to China. It will be necessary in case the exhibitor intends to claim for damage or loss in China.

请参展商携带一份保险单到中国,以备发生破损或丢失的索赔工作。

Effective from 01 January 2006, Chinese Quarantine Authority strictly request that all cargoes with wooden packing, from all Countries and regions, must undertake fumigation treatment. Please refer to following details:

Observe scope适用范围:

All non-manufactured wood packaging material to be used to carry, pack, pad and support, and reinforce the goods, such as wood case, crate, pallet, frame, pal, wood pole, wedge, sleeper and pad.


The Mark should contain the valid symbol approved by IPPC, country code, unique number of producer / treatment designated by the National Plant Protection Organization (NPPO) of exporting countries and treatment methods (HT, MB)
